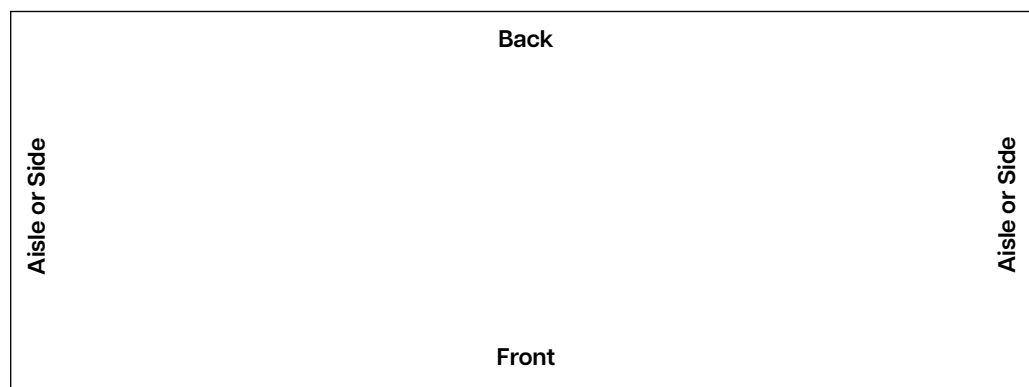

- Multi-way outlets (power boards) with overload protectors must be approved for use by the Event electrician.
- No person is permitted to carry out electrical work on RASWA grounds other than the event electrician, unless otherwise approved by RASWA.
- **NOTE: DOUBLE ADAPTORS ARE NOT PERMITTED ON SITE AND WILL BE REMOVED IF FOUND IN USE.**
- Testing and Tagging carried out during bump in and/or the Event will incur a late fee of \$25.00 + GST unless booked in prior.
- All Vendors agree and acknowledge that leads are not supplied with electrical connection points. Hiring of leads is to be discussed with RASWA prior to **14 August 2026**. Pricing is given on application.
- Once all ordered electrical connections are in place, the Vendor is responsible for plugging their equipment in.
- All electrical equipment must have current test tags. The Event electrician has the right to remove any electrical defective equipment that does not have a current tag and does not comply with Australian Standards.
- Unnecessary delays or late entry surcharges can be avoided by ensuring that RASWA receives your completed electrical requirements form by **14 August 2026**. In the event of cancellation or withdrawal from the Show by an Exhibitor, all monies will be forfeited.
- I/we hereby apply to have electrical requirements installed by the Event electrician, subject to the conditions listed in the Perth Royal Show Site Rules and Regulations.
